SWAN service referrals should continue

While the end of fiscal year 2014-2015 quickly approaches, some Statewide Adoption and Permanency Network (SWAN) needs based budget (NBB) dollars from this fiscal year are not yet spent. We encourage counties to continue to make referrals for children and families who need services.

For referrals to be applied to the FY 2014-2015 NBB, counties must submit referrals to the SWAN prime contractor by 11:59 p.m. on Tuesday, June 30, 2015. Any referral received after this cut-off time will be held and then processed in FY 2015-2016.

DEPARTMENT OF HUMAN SERVICES

If your county has exhausted its SWAN FY 2014-2015 NBB dollars, do not stop referring. The Department of Human Services has authorized reallocation of these funds among counties so the use of these dollars can be maximized. The SWAN prime contractor will continue to process referrals received for FY 2014-2015 until the NBB dollars are exhausted.

SWAN affiliate contracts extended

The Department of Human Services issued a 90-day contract extension of the SWAN prime contract effective July 1, 2015. Thus, affiliate contracts will be extended as well, subject to the terms and conditions of the original *Purchase of Affiliate Services Agreement*.

Affiliate contract extensions are being distributed now. Please respond to the extensions as soon as they are received. Diakon will continue to process service referrals but will not reimburse for services referred on or after July 1, 2015 until the contract extensions are signed and received.

Diakon/FDR is pleased to continue services to the network.

Concurrent goal requirements and update

Effective July 1, 2015 the Concurrent Planning Policy and Implementation Bulletin mandates that all children entering foster care with a goal of reunification must have a concurrent goal identified for them. In addition, effective January 1, 2016, all children who were already in out of home care must have a concurrent goal, regardless of their court-ordered permanency goal. As you are aware, the SWAN portal currently allows entry of both the primary and concurrent goals and the goal dates.

Please note that unlike the primary goal, which is court-ordered, the concurrent goal is not required to be court-ordered. Thus, the concurrent goal and date that is entered can be determined by the county or be the court-ordered date whenever that is established.

The network will be notified as the child form instructions will soon be updated related to the "Court-ordered Date," for concurrent goal.

New SWAN template under development

As part of the ongoing revisions to update and improve the SWAN templates, the SWAN prime contractor is developing a template and guidelines for completing the Finalization Supervisory Report.

This new template is being created based on feedback from the network during unit of service meetings and site visits. The template will provide a format to complete the report as outlined in Attachment H, Supervisory Reports from the Statewide Adoption and Permanency Network bulletin. The guidelines will outline specific topics to address under each of the headings in Attachment H.

The new template will also complement the work that is being completed on the SWAN Individual Permanency Support Plan (IPSP). When finalized, these forms will be available at www.diakon-swan.org and will be available as part of the benchmarks.

(continued from page 1) information about the SWAN Legal Services Initiative, Pennsylvania Adoption Exchange, Helpline and Pennsylvania State Resource Family Association will be included. The toolkit will be a user friendly resource that, when fully functional, will offer sharing opportunities, including chat forums.

Finalization update

During the third quarter of fiscal year 2014-2015 (January-March 2015), 228 children, including 30 older children (ages 13-21), completed the SWAN adoption finalization service. For children making the transition from foster care to the permanency option selected for them, Child Preparation is offered through the SWAN program. The collaboration of SWAN and the Independent Living (IL) Program encourages the use of Child Preparation to ensure older youth are better able to make connections.

- In each year since 2010, more than 900 children aged 13 or older completed Child Preparation.
- In the most recent quarter, 423 children aged 13 or older started Child Preparation.

JIFF Implementation Update

At the May Post-Permanency Units of Service (US) meetings, affiliates were kept up-to-date with the implementation of the Juvenile Inventory for Functioning (JIFF), which will be used to complement the current Post-Permanency assessment tools. Use of the JIFF will become effective by the end of August 2015, and the SWAN portal will be updated to include the application.

The computer-based JIFF is an interactive tool that will be used with youth aged 11 and older. Whenever the JIFF assessment is put into service, the Child and Adolescent Functional Scale (CAFAS) and the Family Adaptability and Cohesion Scale (FACESIII) need not be used.

An email will be sent to the Post-Permanency key contacts in the near future, asking them to identify staff that will be using the JIFF. Please be on the lookout for this email.
