#### **National Adoption Month**

November is National Adoption Awareness Month. # **Chafee Education and Training Grant Program**

The Pennsylvania Chafee Education and Training Grant (ETG) application for the 2016–17 school year and directions on how to apply are available online at www.pheaa.org/funding-opportunities/ other-educational-aid/chafee-program.shtml. The 2016–17 maximum ETG award has been increased to \$5,000 per student, not to exceed their cost of attendance.

Please continue to spread the word about the ETG for youth who are, or were, in out-of-home placement or adopted after age 16. Youth **are not** required to participate in a formal independent living program to be eligible to apply and receive an award. Timely completion of the Free Application for Federal Student Aid (FAFSA), the Pennsylvania State Grant and ETG applications is important. All current ETG award recipients will be automatically enrolled for the next academic year and do not need to complete the ETG application.

# Free Application for Federal Student Aid (FAFSA) Changes

Students who will graduate from high school or complete a GED in 2017 can apply for financial aid starting on October 1, 2016, rather than waiting until January of their senior year. This change will allow students to apply for financial aid using actual data rather than estimates at the same time that they typically start to apply for college admission. It's hoped that students will make more informed college decisions if they have financial aid information at the same time as admissions decisions.

To make that possible, FAFSA and the Pennsylvania Higher Education Assistance Agency (PHEAA) will use the prior year's tax return for aid consideration in 2017–18. For example, an application for 2017–18 financial aid will use income from the 2015 tax return. Youth and independent living/transition staff should look for financial aid nights in your local area in late spring or early in the fall of 2016—and be aware that financial aid deadlines for priority processing may change at some colleges and universities. Please note, some funding is available on a first-come, first-served basis.

**Pay attention** to the deadlines! There are federal and state deadlines, and your colleges may also have a deadline. August 1, 2017, is the deadline for youth attending college in Pennsylvania and all first-time applicants enrolled in a community







college; business/trade/technical school; hospital school of nursing; designated Pennsylvania Open-Admission institution; or nontransferable two-year program. All other applicants must meet the May 1, 2017 deadline.

#### **National Youth In Transition Database**

The National Youth in Transition Database (NYTD) implementation is ongoing with the baseline population (every youth in foster care who reaches age 17) and the served population (any youth receiving independent living services regardless of age) collection period, which begins October 1, 2016. #### Accurint<sup>®</sup>

Accurint is a useful tool for obtaining an individual's address and phone number (landline), but did you know that you can search for cellphone numbers too? By running a separate search called Real-Time Phones, you can access phone records in real time. Try it out and greatly improve your search efforts! #### **Credit-Reporting Requirements**

Credit-reporting requirements changed in September 2015. All youth in foster care ages 14 and older must receive their credit report annually and be given a copy of their credit history upon exiting care. If you are having trouble obtaining credit reports from Equifax®, Experian® or TransUnion<sup>®</sup> or have any credit-reporting questions, contact Belinda Eigen at beigen@pa.gov or 717-787-2726.

#### Safe Haven

We need counties to help in tracking newborn relinquishments. Please contact our office if you have questions about how recent changes to the Newborn Protection Act affects your county and/or where to obtain relinquishment forms. If your agency has not provided relinguishment forms on any Safe Haven newborns, please be sure to do so as soon as possible. #### Child Preparation "Recipes for Success"

The SWAN prime contract, Diakon/FDR, is excited to announce the SWAN Child Preparation Recipes for Success will be updated in the coming months. Child Preparation activities from across the state will be compiled into one document and will be available to the network through the SWAN prime contract website, Toolkit and online trainings. Any SWAN affiliate or Child Preparation worker is invited to submit a Child Preparation activity for possible inclusion in the Recipes for Success. # **Virtual Support Groups**

Post-permanency affiliates are encouraged to submit proposals for virtual Post-permanency support groups. These groups can use any available technology, including conference calls and WebEx. Virtual support groups allow affiliates to reach a larger group than is available in their geographic area.

Some ideas for virtual support groups include:

- "Lunch and learn" sessions
- Book discussion groups
- Kinship groups
- Teen groups
- International adoption groups

#### PAE and RFR: What Should I Know?

The past six months have seen many changes within and around the Resource Family Registry (RFR) and the Pennsylvania Adoption Exchange (PAE). The following are some quick references to things you should know:

 Electronic matching has been updated, and families will only get matches in the age range the family specifies.

- The algorithm has been intensified and there must be a 70 percent overall match score on the demographic, and important and critical characteristics increased from a 40 percent match. There will now be many families and children who get zero matches.
- Make sure the age, gender, race and number of siblings the family is willing to accept are accurate. PAE will no longer match outside these guidelines.
- There is no longer a wait period for families after being matched; this makes it more important than ever to move on matches immediately.
- Family-to-child matching will resume; for the past few years electronic matching was done exclusively child to family. This means when you register a family as wanting to adopt you should expect to receive electronic matches for that family.
  - If you receive zero matches for the family, this indicates that the family's acceptable characteristics and demographics are outside the characteristics and demographics of waiting children, and you may want to review these selections with your family.
  - If your family is selected for a child, please email PAE (dsariano@diakon-swan.org) and ask to have the family placed on a hold status.
- Customized matching for children is always available through your PAE coordinator. They can match for region of the state for children who do not have terminated parental rights.
- Any child with a "county-established" goal of adoption (either a primary or concurrent goal) is eligible for PAE registration, but is not required to be registered with PAE.
- Any child receiving child-specific recruitment **must** be registered with PAE.
- Eighty-seven percent of children who are registered with PAE and need a permanency resource achieve permanency (stats since 2010).
- The list of recruitment strategies PAE coordinators preach are now available to view in the SWAN Portal. It is very exciting to see all efforts recorded.
- We are working to create a process to allow

other TV stations and other taped children to also be featured on www.adoptpakids.org. Stay tuned.

- You will see an increased focus on making the information in the RFR right.
  - ♦ Jen Casner-Hockenberry is going to lead this effort.
  - Our records say there are 1,400 families who want to adopt, and we are going to do everything we can to make sure this is 100 percent accurate.
  - Overall, our system says that there are more than 20,000 families—either kinship, foster care or adoption—who are active in the state. It is important to make this information as accurate as possible too.
  - You can expect to hear regularly from your RTAs and PAE to place on hold families who no longer want to adopt and to close families who are no longer in the process.

## SWAN Helpline — Post-Permanency

The SWAN Helpline is the entry point for families wishing to access SWAN Post-permanency services. These services are family-driven, requiring families to reach out to the SWAN Helpline by calling 1-800-585-SWAN or emailing SWANHelpline@diakonswan.org.

As a reminder, when families call to be reassessed for additional services, all previous services must be invoiced.

## SWAN Helpline — Matching Events

The SWAN Helpline assists families throughout the whole process of adoption, from initially obtaining information to taking referrals for Post-permanency services. When families are involved in the matching phase of the process, Helpline can inform them about upcoming adoption matching events going on in their area. Agencies and PAE coordinators can seek Helpline's assistance in notifying families of future events in order to increase attendance; PAE can help generate a list of approved adoptive families in the area, and Helpline can call the families to inform or remind them of these events.

Even if this service is not needed, it is helpful to


inform the Helpline about upcoming adoption matching events. Lynette Lemke, SWAN technical specialist, maintain a matching events calendar, and regularly adds events as she becomes aware of them. Helpline can refer to this calendar when families call to inquire about future events. Families have reported that it is helpful to meet agencies and waiting children in person during the matching process, so it is beneficial to keep us updated and involved since we speak to families regularly.

#### **Update on Finalizations**

During the fourth quarter of state fiscal year (SFY) 2016 (April–June 2016), 339 children, including 34 older children (age 13 and older), completed the SWAN adoption finalization service.

According to SWAN Portal data, 194 older children were discharged during the SFY 2015–16. Among them, 166 older children achieved permanent arrangements, including 132 adoptions. Compared to SFY 2014–15, among all discharged older children, the number of older children who achieved permanency increased from 80 percent to 85.6 percent, the number of children who aged out decreased from 8.9 percent to 6.7 percent.
