National Youth in Transition Database

The National Youth in Transition Database (NYTD) implementation is ongoing with the Baseline Population (every youth in foster care who reaches age 17), Served Population (any youth receiving independent living services regardless of age) and Follow-up Population (youth surveys at age 19 and 21 depending on Cohort period). Pennsylvania is currently in Cohort 3 with 19-year old Follow-up Surveys. Counties can log onto www.GetNYTD to see the 19-year-old youth who need to be surveyed during this reporting period. The deadline for collecting survey information is September 30, 2019. NYTD questions can be directed to Teresa Musser, Office of Children, Youth and Families, at temusser@pa.gov or at 717-214-7385.

Medical Assistance Bulletin Released Updating Childhood and Adolescent Immunization Schedule

On April 22, 2019, the Office of Medical Assistance Programs issued Bulletin 99-19-01: 2019 Recommended Childhood and Adolescent Immunization Schedule. This bulletin updated the immunization schedule for children and youth aged 18 or younger. Quality Service Reviews

The Quality Service Review (QSR) is one critical component of Pennsylvania's child welfare Continuous Quality Improvement (CQI) system. The QSR involves a team of certified QSR reviewers gathering information directly from families, children and service team members so that they can assess the current safety, permanency and well-being of a child/youth while also evaluating the system's ability to implement Pennsylvania's Practice Model, which provides a basis for promoting and strengthening best practice. QSRs will occur during the fall of 2019 in Mifflin, Blair and Cumberland Counties. Federal Bureau of Investigations (FBI) Criminal History Fee Increase

As of January 1, 2019, the Federal Bureau of Investigations (FBI) has increased the cost for the federal criminal history clearance to \$23.85 for employees and \$22.60 for volunteers.

Child and Family Service Reviews

The Child and Family Services Review (CFSR) was established by the federal Administration for Children and Families (ACF), Children's Bureau (CB) to ensure states' conformity with federal child welfare requirements, to determine what is experienced by children and families as they are engaged in child welfare services and to assist states in enhancing their capacity to help children and families achieve positive outcomes. The CFSR focuses on the assessment of safety, permanency and well-being outcomes, as well as seven systemic factors. Pennsylvania conducted CFSR case reviews in 2017 and has developed a program improvement plan to address outcomes where Pennsylvania did not meet federal performance standards. Pennsylvania has conducted case reviews in Butler, Mercer, and Centre counties as part of the program improvement plan monitoring phase of the federal CFSR process. Lycoming, Northampton, Philadelphia and Lehigh will be conducting their case reviews now through the end of July. Act 54/Plans of Safe Care

The Pennsylvania Departments of Drug and Alcohol Programs, Health, and Human Services have issued the Pennsylvania Plan of Safe Care Guidance to provide practice considerations related to identification of infants and caregivers affected by substance use and substance use disorders, parameters related to development of plans of safe care including plan elements, development, and monitoring. To assist county children and youth agencies considering the potential practice and fiscal impacts related to serving infants and their families impacted by substance use and substance use disorders, the Governor's Institute is hosting five regional, in-person, two-day work sessions for county planning teams responsible for implementing plans of safe care for infants affected by prenatal substance exposure, including alcohol, and their families. Mandated Reporter Training

Mandated reporter training is crucial in the identification and prevention of child abuse and neglect. To help ensure as many mandated reporters are trained as possible, OCYF contracts with three organizations to provide either in-person or online mandated reporter training. In just the past year, over 200,000 mandated reporters have been provided training through these organization.

Pennsylvania Family Support Alliance (PFSA) offers in-person trainings to any mandated reporter groups, while the Pennsylvania American Academy of Pediatrics (AAP), who also offers in-person trainings, only serves medical professionals, school nurses, and emergency management services. The Pennsylvania Child Welfare Resource Center (CWRC) offers an online training course for any mandated reporter or others needing to complete a mandated reporter training course. Fiscal Year 2018-2019 Referrals

While the end of state fiscal year (SFY) 2018-2019 quickly approaches, some Statewide Adoption and Permanency Network (SWAN) Needs Based Plan and Budget (NBPB) dollars from this SFY are not yet spent. We encourage counties to continue to make referrals for children and families who need services.

For referrals to be applied to the FY 2018-2019 NBPB, counties must submit referrals to the SWAN prime contractor by 11:59 p.m. on Sunday, June 30, 2019. Any referrals received after this cut-off time will be held and then processed in FY 2019-2020.

If your county has exhausted its SWAN FY 2018-2019 NBPB dollars, do not stop referring. The Office of Children, Youth and Families has authorized reallocation of these funds among counties so the use of these dollars can be maximized. The SWAN prime contractor will continue to process referrals received for FY 2018-2019 until the NBPB dollars are exhausted.

SWAN LSI Diligent Search Packet Updated

The 2019 edition of the SWAN LSI Diligent Search Packet includes up-to-date information to help ensure agencies are in compliance with both new and existing laws related to diligent search.

With every revision, a committee thoroughly reviews information included in the packet. This extensive process ensures searchers have the most effective resources available and that resources are organized to streamline the search process for your particular timelines and requirements. So whether you are a seasoned searcher or this is your first time searching, you will be able to pick up the packet and begin your process from page one. A checklist is always included in the Attachments section to help guide your search and later support your documentation requirements for courts.

LSI continues to strive to help Pennsylvania comply with national guidelines for search efforts. We have included important links to other helpful documents to assist you with your search, such as Family Design Resources' *Indian Child Welfare Act Search Guide* and the *SWAN LSI Incarceration Resource Manual*.

SWAN Legal Services Initiative: A Decade of Growth and Progress

Beginning in state fiscal year (SFY) 2009-10, County Children and Youth Agencies (CCYAs) could request SWAN Legal Services Initiative (LSI) paralegals within their Needs Based Plan and Budget. This change was due to the state's support of counties to fully realize program benefits and served as a catalyst for rapid, widespread program growth. The following are milestones that highlight LSI's growth over the last ten years:

- LSI paralegal positions grew from 18 to more than 240;
- Expanded support from 14 to all 67 counties by SFY 2015-16;
- Completed numerous updates to the *Diligent Search Packet*;
- Partnered with the Pennsylvania Adoption Exchange to release *Adoption Day Events: A Planner's Guide*;
- Collaborated in the development of the *Incarceration Resource Manual*;
- Streamlined and integrated data collection systems with the SWAN Portal; and
- Provided diligent search activities to assist in the administration of National Youth in Transition Database surveys.

In the last five years, LSI has:

- Completed more than 74,000 diligent search activities;
- Drafted more than 220,000 court documents; and
- Impacted more than 81,000 children with at least one LSI activity.

SWAN LSI remains focused on achieving program outcomes that contribute to expediting permanency for children and families in Pennsylvania.

Child Preparation Recipes for Success

Incarceration Resource Manual Tool for Case-Planning

Working with incarcerated parents who are involved in the child welfare system can be challenging due to differences among individual county prisons' policies, procedures and available services. The *SWAN LSI Incarceration Resource Manual* (IRM) compiles county prison policies and procedures into a single, comprehensive document.

This manual contains entries for each Pennsylvania county prison. It is intended to be a tool to assist caseworkers and supervisors in their case-planning with incarcerated parents, as well as be a resource to support the counties' efforts to engage with these parties. The second edition provides links to additional resources, including state and federal facilities.

National Adoption Month Preparation

Throughout the month of November, county and affiliate agencies have hosted wonderful events to celebrate National Adoption Month. These events raise awareness about the need for adoptive families for children and youth in out-of-home care, celebrate the creation of forever families through adoption and seek to match waiting children with their forever families.

The SWAN prime contractor is currently updating two resources designed to help counties and affiliates plan National Adoption Month events. The *Adoption Day Events: A Planner's Guide* and *Adoption Awareness and Matching Events: Planning for Success* will be available on diakon-swan.org soon, in anticipation of National Adoption Month.

PAE-Registered Children and Out-of-State Families

According to SWAN Portal data, as of May 2019, 42 percent of families seeking to adopt a child in Pennsylvania are, first, from other states and, secondly, also the most willing to accept older children. Children who are 13 years of age and older are the largest population of waiting children registered with the Pennsylvania Adoption Exchange (PAE). As a result, caseworkers for older youth receive many inquiries from out-of-state families.

If you are working with older youth, the Interstate Compact on the Placement of Children (ICPC) will guide placement with out-of-state families. The ICPC is a statutory agreement among all 50 states, including the District of Columbia and the U.S. Virgin Islands, that provides for the movement and safe placement of children between states. It helps connect child welfare agencies throughout the country to ensure the safety of out-of-state placements. More information about the ICPC can be found on the SWAN Toolkit at swantoolkit.org.

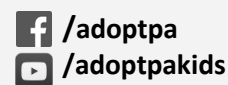
